Join us to celebrate the holidays at our annual winter gathering.



FROM DOWNTOWN: GO SOUTH ON ORANGE AVE; TURN RIGHT ON HOLDEN AVENUE; GO APPROX. 0.8 MILE; TURN LEFT ON JESSAMINE LANE;

FROM I-4: TAKE EXIT 33 (441/17-92/ORANGE BLOSSOM TRAIL); GO SOUTH ON OBT; TURN LEFT ON HOLDEN (2nd traffic light); GO APPROX. 0.7 MILE TO JESSAMINE LANE (THE ORANGE GROVE IS GONE, THERE IS A NEW SUBDIVISION BEING BUILT ON THE CORNER); TURN RIGHT ONTO

ONCE ON JESSAMINE: GO APPROX. 0.7 MILE DOWN JESSAMINE LANE. THE GATE WILL BE SCHEDULED TO BE OPEN AROUND ARRIVAL TIME BUT CAN'T STAY THAT WAY FOR THE ENTIRE PARTY, SO IF YOU'RE ARRIVING LATE YOU'LL HAVE TO CALL. Important: Per Article XIII, Standards for Divers, Section 4, Refunds of the Orlando Reef Divers Bylaws once a deposit is paid, there shall be no refunds for moneys paid for dive outings. The committed participant is responsible for all unrecoverable trip costs due unless he/she finds a replacement. The only exception is cancellation due to death in the immediate family. All recoverable moneys will be refunded should a portion of a dive outing be canceled by the Club. If an entire trip is canceled by the club, all moneys will be refunded.



Report for ORD dive trip - Riviera Beach September 20 - 21, 2025

Originally this dive was planned with Shellback Aquatics, but due to mechanical problems with their boat they canceled on us. Our heroic dive coordinator Stephanie scrambled on Thursday and found us replacement boats: Narcosis on Saturday and Stuart Scuba on Sunday. Narcosis was a nice boat with a great crew. They sent down 3 guides with the divers - two with ORD and one with the other guests on the boat, so none of us had to carry a flag. The weather was rough, making it challenging to climb back on the boat, and two of us got sick. One member stayed at the hotel rather than face it. On Sunday it was predicted to be equally rough, and the Stuart Scuba boat was smaller, so all but one of us decided to skip the dive and head home early.

Roatan Aggressor May 23 – 30, 2026 Member \$3,081 Non-Member \$3,111



Roatan is ideally situated along the Mesoamerican Barrier Reef System, the second largest barrier reef in the world. This extensive reef attracts a wide variety of marine animals and feeds the Bay Islands with healthy and diverse populations of fish and other marine creatures, making it a true diver's delight.

The Bay Islands of Honduras consist of eight islands and 53 small cays located off the northern coast of Honduras. Our Roatan diving liveaboard trip in Honduras departs from the dock located at Roatan Yacht Club & Marina. The 7-night charter runs from Saturday to Saturday.

- Diving begins Sunday morning and ends Friday around noon when the Aggressor returns to port.
- Average of up to 27 dives on 7-night charters including night dives.
- Depth Range: 30 130 ft (9m 40m)
- 3-5 mm wetsuit recommended
- Average water temperatures: 78-84F, 25-28C (summer) 75–80F, 24-27C (winter, with possible 72F, 22C drop in January)

4 deluxe double-occupied rooms available. Air is included in this fee; nitrox is available at an additional charge of \$100 paid directly to the boat. Required fees **NOT** included in the trip fee:

- \$40 (\$20 each way) airport transfer fees
- \$145 park fee paid in cash upon boarding liveaboard.

The boarding is between 3:30 and 4:30 May 23rd and check out is 8:00 am on May 30th.

NOTE: Airfare, gratuities and hotel (if you choose to come early) are not included in the liveaboard fee.

A \$500 deposit is required to reserve a spot. Remaining payments due as follows: August 15, 2025 - \$1,000; November 15, 2025 - \$1,000; Final payment of \$481 due January 15,

2026. Although you can make payments before or on these dates with a check, please use Zelle if possible, to: orlandoreefdiversclub@gmail.com and indicate you are paying for the Roatan trip.
